## 3. Cost

- 3.1. The cost is calculated based on the registered care days and times. The current pricelist can be found on the Mini Meadows homepage.
- 3.2. The care fees have to be paid on a monthly basis by the 1st of the current month.
- 3.3. The regular schedule is from 7:00 to 18:30, Fridays until 18:00.
- 3.4. The non-refundable registration fee of 250 CHF per child is due upon signing the contract.
- 3.5. The first monthly fees are due on the first official day of the child.
- 3.6. The fees are applicable for the full year (12 months) and include times the child might be absent (closing days, vacations and sickness). The fees must be paid up to and including the notice period.
- 3.7. A 10 % reduction in fees (excl. evening care and other specials) is applicable for each additional child from the same family attending Mini Meadows GmbH at the same time.
- 3.8. Changes in the contract have to be announced 4 weeks prior to execution. Adaptions and changes will be granted if available.

## 4. Insurance / Liability

- 4.1. Parents are required to have liability insurance for their child and are responsible for the health and accident insurance of the child.
- 4.2. If any damage is caused by a child, the parents and/or their private liability insurance will be responsible for reimbursing Mini Meadows GmbH for the damage.
- 4.3. Mini Meadows GmbH has its own liability insurance.

## 5. Illness / Accidents / Medication

- 5.1. Parents are kindly asked not to bring any child who is sick or has a fever to Mini Meadows and also inform by 8 am of the same day via phone or mail.
- 5.2. If a child becomes unwell during class, parents will be informed by phone and asked to fetch the child within one hour. This also applies if the child is ill upon arrival.
- 5.3. After an illness, the child must be at least 24 hours symptom- and fever free without medication before returning to crèche.
- 5.4. Mini Meadows does not give medication to a child unless it is homeopathic medicine.
- 5.5. In case of accident, the Mini Meadows staff will ensure that the child is given first aid, medical assistance or hospital care, as necessary. The parents will be notified immediately.
- 5.6. Small wounds will be cleaned, disinfected and bandaged by Mini Meadows.
- 5.7. Illnesses, allergies and other health conditions must be indicated under article 5.8 upon signing this contract. New, additional health issues must be reported in writing.

## 9. Termination of the contract

- 9.1. In the interests of the child, the parents and Mini Meadows GmbH, the first three months will be classified as a trial period. During this time, a notice of 4 weeks must be given to the end of the month.
- 9.2. After the trial period, the contract can be terminated by either part (the parents or Mini Meadows GmbH) effective at the end of the month with 3 months' notice.
- 9.3. Notice must be given in writing.
- 9.4. If the notice period is not adhered to, if the child does not or no longer attend Mini Meadows after giving notice, the fees for the time until the termination of the contract applies, will be due and have to be paid.

## 10. Jurisdiction

The exclusive place of jurisdiction for all disputes from this contract is Bülach, Switzerland.

## 11. Signature
